# Swim School Membership Terms & Conditions

## 1. Introduction

- 1.1. This is an important document. It records the terms and conditions of your Swim School Membership with the Adelaide Aquatic Centre (AAC) and your right to make use of the aquatic facilities during the period of your membership. You should read this document carefully.
- 1.2. The AAC rules may change from time to time. The most up-to-date AAC rules will always apply. You will find a copy of the most up-to-date AAC rules by visiting our website:

## 2. Membership Application

- 2.1. You may apply for Swim School membership with AAC.
- 2.2. We will only consider an application for membership upon receipt of a satisfactorily completed and signed membership / enrolment application.
- 2.3. Where a proposed member is under 18 years, a membership application must be completed and signed by the parent or guardian of the applicant, who will be bound by the membership contract.
- 2.4. We reserve the right to refuse any membership application without ascribing any reason therefore.

## 3. Periodic Agreement

- 3.1. Swim School memberships at AAC are a Periodic Agreement that continue on a periodic basis from Supply Period to Supply Period until terminated in accordance with section 5.

## 4. Swim School Supply Period

- 4.1. All AAC direct debit Swim School memberships have a 4-week Supply Period.

## 5. Direct Debit Membership Cancellation

- 5.1. To cancel your direct debit membership, you are required to provide a cancellation request, cancellations requests must be provided a minimum of 7 days prior to your intended cancellation date.
- 5.2. You can cancel the Periodic Agreement with earlier effect than the End Time but you will still be liable for the Membership Fees to the End Time, unless agreed to by management.

## 6. Price Increases and Changes to Membership

- 6.1. Members will be given at least 14 days' notice of any changes to the price or structure of the relevant membership. All efforts will be made to notify members in writing dependant on current database contact details, as well as email, web and facility notices.
- 6.2. If a member does not agree with a material change to the price or structure of the relevant membership, the member may terminate his or her membership by following the cancellation procedure outlined in section 5.

## 7. Change of Rules/Terms & Conditions

- 7.1. The Terms and Conditions of entry to the AAC (displayed at front entrance and on website) apply to all members, casual visitors and spectators, and are subject to change.

## 8. No Lesson Periods

- 8.1. During the designated No Lesson Period all Swim School Memberships direct debits will be automatically suspended and members will not be charged for this time, however if your account is financially up to date students can access the facilities during this time.
- 8.2. Annual designated No Lesson Period dates will be communicated to all Swim School members by the conclusion of February each year by the AAC website, email and displayed on centre noticeboards.

## 9. Membership Suspension

- 9.1. Two weeks' voluntary suspension can be taken throughout the year where you suspend your membership in accordance with this clause:
  - 9.1.1 we will not charge you a suspension fee;
  - 9.1.2 suspensions must be taken in blocks of 7 days;
  - 9.1.3 all of your membership entry entitlements will be suspended during the suspension period;
  - 9.1.4 you are entitled to two weeks' voluntary suspension per calendar year, per student.

9.2. Before you voluntarily suspend your membership, you must inform us in writing that your membership will be voluntarily suspended at least 7 days prior to the time the period of voluntary suspension begins.

9.3. If you are unable to attend Swim School Membership lessons, you may be entitled to a partial credit of the membership fees, where:

- a minimum of two and maximum of four consecutive lessons have been missed due to medical reasons;
- a written application for credit has been received by us within four weeks of the later of the missed lessons; and
- an appropriate medical certificate is provided to us with the application for credit, a pro-rata credit, up to a maximum of 50 per cent of the membership fee paid, will be issued which may be applied against future membership fees. Fees will not be refunded.

## 10. Missed Lessons

10.1. If the Learn to Swim member cannot attend a lesson, they can collect a Missed Lesson Pass from the Customer Service Office after the missed lesson has occurred.

10.2. This pass allows the Learn to Swim member, family or friends to utilise the facility for free within three (3) months of the missed lesson, on any day of the week. Passes will become void after this time.

10.3. Each pass is valid for a single use only and cannot be redeemed for credit or cash or in exchange for any other product or service.

10.4. If your card is lost, stolen or faulty please inform the Customer Service Office immediately. A \$2 replacement fee is applicable.

10.5. The Learn to Swim member has a choice of three (3) pass types.

10.6. Where a lesson is cancelled by AAC Swim School a one (1) lesson credit will be applied to your account based on the current per lesson fee.

## 11. Direct Debit Payments

11.1. All information regarding direct debit payments can be found in the DDR terms and conditions which can be found in facility or via the AAC website.

11.2. If EziDebit fails to debit your account on 3 consecutive debits cycles, we will remove the student from the program and issue an invoice for the total amount owing.

11.3. If a transaction dispute is raised for your Swim School Membership with your bank, we will supply both you and EziDebit with a copy of the signed Swim School Membership Form and Direct Debit Request. We ask that you cancel the dispute with your bank, failure to do so may result in additional fees incurred which will be invoiced to you.

## 12. Replacement Cards

12.1. Replacement cards can be issued at a cost of \$2.

## 13. Privacy

13.1. When you join and during your membership, we will have access to personal information about you, such as about your health and financial situation. We will only use, disclose or deal with your information in accordance with our privacy policy.

13.2. We may sometimes film or photograph the facilities. It is possible you may appear in the background. By entering into this membership contract, you agree to allow us to use your image in promotional and other business related material.

## 14. Management Rights

14.1. Facility access is subject to change and availability at AAC's absolute discretion without notice. During major events, members may have limited access to facilities including pools, classes, car parking and other products and services. AAC management reserves the right to alter the Swim School program at any time. This may include but is not limited to changing class times, instructors or format.

## 15. Student Behaviour

15.1. Inappropriate student behaviour is not acceptable and management reserves the right to remove a student from a lesson. No liability will be held by the AAC.
