## YMCA 'AAC PRE-SALE' PROMOTION - TERMS AND CONDITIONS

### 1. OFFER AND ELIGIBILITY

- 1.1. This 'AAC Pre-Sale' promotion is offered by YMCA Aquatic & Event Services Limited, Jeffcott Road, North Adelaide SA 5006.
- 1.2. By participating in the Promotion, you agree to be bound by these Terms.
- 1.3. The Promotion is only available at Adelaide Aquatic Centre (AAC) between the dates of 8 November 2025 up to one day before the official centre opening date in early 2026 (Promotion Period).

### 2. OFFER STAGES

- 2.1. This promotion uses a series of decreasing stages based on number of memberships sold during this period. It also incorporates a stage for pre-existing Health & Wellness/Centre members to have exclusive access to the pre-sale, with a foundation offer equivalent to the best that will be subsequently offered to the public. Stages will change when either the time-period lapses or the membership unit limit is met. Current offer availability will be shared on the centre website.

#### 2.2. **Membership offer stages and unit limits:**

Previous members have 72 hours prior to public Stage 1 with a choice of:

- 50% off 12-month term membership & \$0 joining fee – unlimited
- 30% off flexi membership & \$0 joining fee – unlimited

Public Stages include:

- i. Stage One A - 50% off 12-month term membership & \$0 joining fee - 100 units  
\*If/when Stage One A is exhausted, offer Stage One B will change to any membership type, subject to the total allocation of 400 units as not be exhausted at such time.
- ii. Stage One B - 30% off flexi membership (or any) & \$0 joining fee - 400 units\*
- iii. Stage Two - 20% off any membership & \$0 joining fee - 500 units
- iv. Stage Three - 15% off any membership & \$0 joining fee - 500 units

### 3. TO BE ELIGIBLE FOR THE PROMOTION

- 3.1. You must not be an existing member at the relevant Participating centre; and
- 3.2. You must become a Member at the Participating Centre within the Promotion Period.
- 3.3. For the avoidance of doubt, the Promotion does not apply if you sign up for Swimming Lessons at the Participating Centre.

3.4. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

#### **4. SIGN UP TERMS**

- 4.1. All other applicable fees and charges in respect of the membership will be payable in accordance with the applicable membership terms. Your membership will otherwise be governed by such membership terms.
- 4.2. The Promotion is only available at Participating Centre.
- 4.3. To qualify, you must be 18+ years old and a new member.
- 4.4. Offer non-transferable and not redeemable for cash.

- 6.3. Any dispute or situation not covered by these terms, will be resolved by YMCA management in a manner it deems to be fair (acting reasonably)
- 6.4. These terms are governed by the laws of Victoria, Australia.
- 6.5. Members will be bound by their terms of membership with YMCA.
- 6.6. To the extent of any inconsistency between the terms of membership and these Terms, these Terms will take priority.
